

# Minutes of the City Council

Wednesday, May 24, 2017

Special Meeting

The meeting was held in the City Hall and called to order at 4:00 PM by Mayor Tom Schoaf.

#### II. Business

#### A. Scout Park Sidewalk Recommendation of Award of Contract for Construction

Mr. Culbreth stated the reason for the early meeting is because he has been informed that The Wigwam is closing the Heritage Course on June 5 and will be closed for a couple of weeks. This is the amount of time we would need to complete this project and he would like to take advantage of the down time.

Mr. Gillespie stated seven bids were received; however, there were two who did not submit references and another company did not acknowledge an addendum, so they were considered non-responsive.

Following a brief discussion, Council Member Romack **moved**, **seconded** by Council Member Mahoney to award the bid to the lowest responsive bidder, Monroy Construction, in the amount of \$55,273.17; **unanimous passage**.

## B. Village Park Parking Lot Improvements Recommendation of Award of Contract for Construction

Mr. Gillespie stated there were a total of seven proposals received and three were considered non-responsive. Two of them, Lincoln Contractors and Stratton Builders, did not provide references and were considered non-responsive. Although Ace Asphalt is the next lowest bidder, he expressed concern due to the fact that their sub-contractors list was blank, which indicates they will not have any subs for this project; Although they submitted references, he could not confirm if they have completed any concrete projects for these references. He is recommending they be disqualified for this reason. Mr. Mahoney asked why Ace Asphalt could not perform the work and hold them accountable and ensure they do it correctly. The response was it would be a significant expense if they had to go that route.

Council Member Blake commented on the bids and the vast difference in the amounts. Mr. Gillespie stated Ace Asphalt may have submitted the bid as a price for asphalt instead of a price for concrete, which could be the reason for the low bid. The next lowest bidder was Monroy Construction, who submitted all the documentation required in the bid, and recommends Council award them in the amount of \$78,111.40.

Mr. Culbreth stated this project must be completed by the end of the 2016-17 FY.

Council Member Blake **moved** to award the contract to Monroy Construction, but the motion **failed** for a lack of a second.

Following a brief discussion, Council Member Romack **moved**, **seconded** by Council Member Raible, to award Ace Asphalt in the amount of \$62,218.56; **unanimous approval**.
